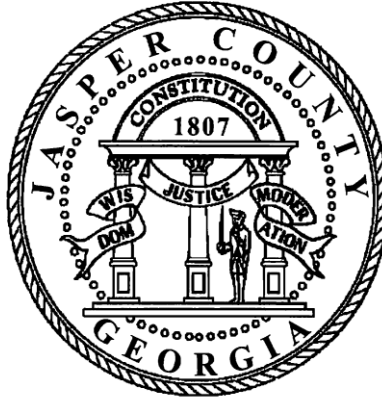

The name and mailing address must be shown on the proposal. A post office box is not acceptable to Jasper County as a mailing address.
